

Fast-track Accreditation to the Green Climate Fund

Version 5.0 (February 2017)

<u>Entities</u> are eligible to apply under the Green Climate Fund's fast-track accreditation process if both criteria are met:

- 1 The entity was accredited by one or more of the following funds by 14 December 2016:
 - a) Global Environment Facility (GEF)
 - b) Adaptation Fund (AF)
 - c) Directorate-General Development and Cooperation EuropeAid of the European Commission (DG DEVCO)
- 2 The entity is in full compliance with the relevant accreditation requirements of the fund(s) they are accredited to:
 - a) GEF's Minimum Fiduciary Standards and Minimum Standards on Environmental and Social Safeguards
 - b) AF's fiduciary standards
 - c) DG DEVCO's fiduciary standards under the pillar assessment for (i) internal control system, (ii) accounting system, (iii) independent external audit, (iv) rules and procedures for grants, (v) procurement and (vi) sub-delegation.
- 3 The entity has been approved by the GCF Board to be included in the list of potentially eligible fast-track entities. Refer to the decisions below:
 - a) Decision B.08/03
 - b) <u>Decision B.10/06</u>
 - c) Decision B.12/30
 - d) Decision B.14/09
 - e) Decision B.15/09

Under the fast-track accreditation process, entities will need to complete the <u>application form</u> to address Green Climate Fund requirements that have not been assessed under the accreditation processes of the other funds listed above.
