2.1 Overall (summary) project progress

This report provides an overview of the project progress during the period August 2020 - December 2020. During this period, progress has mainly focused on project preparation and planning activities for the period January - December 2021, and there have been no execution activities yet.

Preparation activities for project implementation have produced relevant information which was validated in the first Steering Committee (SC), which was formalised on 11 December 2020 (see Annex 1).

The information that has been produced during the preparation activities included the definition of the project's Theory of Change outline (see Annex 2), and the consolidation of the project's Logical Framework Matrix (LFM) with its impact/outcome indicators (see Annex 3) and the identification of the need for information to adjust the baseline of these indicators.

The governance of the project has been discussed and approved. The organisational chart have been endorsed by CONAF and the FAO Representation. It details roles and functions of the different decision-making bodies, including the Steering Committee and the Coordinating Unit (see Annex 4).

Through an extended participatory process between the FAO team, CONAF headquarters and the CONAF regional offices of the 6 regions involved in the project (14 workshops), a detailed definition of the implementation targets for the 7 direct action measures and the 4 cross-cutting measures of the Climate Change and Natural Resources National Strategy (ENCCR - Estrategia Nacional de Cambio Climático y Recursos Vegetacionales) was drawn up for each region. Based on these targets, specific regional procurement and contracting requirements were defined based on the project budget and financing agreement.

An Annual Operational Plan (AOP) 2021 and its relevant Procurement Plan were drawn up based on the project's LFM and the detailed budget with the regional requirements. To facilitate consultation and work on these project planning instruments, an online platform was developed to monitor the execution of the project by the coordination unit.

Following the approval of the AOP by the Steering Committee, progress has been made in the formulation of Terms of Reference and contracting of the project team, the contracting of support services, consultancy services and the purchase of equipment.

Progress has also been made in terms of the 'Communication Strategy', and development of the project corporate image. As of the date of this report, the Steering Committee members have approved that the name of the project for communication purposes during implementation will be: +Bosques "Juntos contra el Cambio Climático" (More Forests: together against climate change).

As a result of the COVID-19 pandemic, in particular mobility restrictions and lockdowns, and changes of authorities in the institutions involved in the project, the Project Launching and Start-up Workshop activities have been delayed, being postponed at the beginning of March 2021.

Given that the project is in the activities planning phase, during the reporting period, there was no implementation of REDD+ activities and investments in the territories, therefore no additional environmental and social changes or risks were identified besides those identified and assessed in the project's Environmental and Social Management Framework (see table 12 of the ESMF). It should be noted that the definition of the activities to be executed and the specific intervention sites is in process, information that will allow the integration of environmental and social management in the planning, implementation and follow-up and monitoring of the project.

On the other hand, according to the project's environmental and social assessment guideline, the overall project classification remains at moderate risk (Category 'B') and it is expected to trigger five of the nine FAO safeguard policies: a) ESS2 Biodiversity, Ecosystems and Natural Habitats; b) ESS3 Plant Genetic Resources for Food and Agriculture; c) ESS7 Decent Work; d) ESS8 Gender Equality; and e) ESS9 Indigenous Peoples and Cultural Heritage.

Based on the analysis of the applicable legal framework and safeguards policies developed in the Environmental and Social Management Framework (ESMF), and considering the level of project progress for the reporting period, the status of compliance with applicable national regulatory framework at the preparation and planning stage is described in section below.

During the reporting period, the implementation of the ESMF has been geared towards preparedness and planning actions, with the objective of preventing some social risks identified in the ESMF such as: i) Strengthening and/or re-emergence of conflicts related to weak and non-transparent internal governance structures regarding access to benefits; ii) Inadequate and/or unfair distribution of benefits, particularly for vulnerable groups as women; and iii) Exclusion or limited participation of relevant local stakeholders, including women in forest-related activities linked to ESS7, ESS8 and ESS9 policies.

In keeping with the same, a process of updating the key stakeholders map was carried out, based on the identification already carried out for the ENCCRV and the project formulation phase, in order to reconfirm or incorporate other potentially relevant stakeholders; together with the Implementing Entity (FAO) and the Safeguards team, in order to identify, mitigate and avoid negative impacts that could affect livelihoods, governability, agricultural systems and indigenous peoples.

In addition, a series of informative meetings were held to raise awareness among key stakeholders and bodies involved in the governance of the ENCCRV project, such as MINAGRI's Inter-Ministerial Technical Committee on Climate Change (CTICC), the Inter-Ministerial Technical Team on Climate Change (ETICC) and the Civil Society Council of CONAF (COSOC). In addition, joint working sessions were held between the regional CONAF and FAO teams, which led to the definition of action measures to be implemented in each territory and, therefore, an orientation regarding the activities to be carried out. This information, added to the socio-environmental context described in the ESMF, will allow the environmental and social assessment and the subsequent categorisation of the subprojects risks.

Finally, during the months of November and December 2020, 13 participatory virtual workshops were held in the 6 regions of the project, with the aim of strengthening governance, risk management and decision-making aspects of the ENCCRV Benefit Distribution System. These sessions were carried out through a process of dialogue in 'Focus Groups[1]', made up of: CONAF, small and medium landowners, consultants and extensionists, indigenous women and small landowners, institutional, academic, private sector, NGO's and indigenous peoples. A total of 328 people participated, of which 45.6% (149) were women and 24.7% (68) belonged to Indigenous Peoples.

4.2 Gender Action Plan

Regarding the progress in the implementation of the gender action plan and considering the project preparation phase, it should be noted that during the reporting period, and as part of the participatory process of the Benefit Distribution System in which the representation of women reached 45.6%, focus groups of only women were carried out with the participation of rural and indigenous women, women's organisations and small forest owners, with the aim of gathering opinions, perceptions and proposals on the system, through a constructive dialogue and with a gender approach.

This gender-sensitive action allowed these women's focus groups to advance in the definition of the gender variable, which will guide all decision-making processes in the ENCCRV results-based payment phase, where the main outcome was the relevance of including, in addition to the benefit of projects presented by women and the number of beneficiaries, a criterion to prioritise those projects that benefit the production of non-wood forest products, technical and environmental education and growth of women's income.

It was also possible to gather women's views and proposals on prevention measures related to project risks and SDB implementation, as well as the incorporation of women's organisations and leaders in the territory to decision-making bodies such as the REDD+ group.

The progress described is in line with Output 2 'Enabling conditions and institutional strengthening for ENCCRV implementation' of the Gender Action Plan and, considering that for the reporting period the project was in the preparation and planning phase, no additional progress to those already described above was identified.
