As GCF nears the end of its first programming period 2020-2023 (GCF-1) and is undergoing replenishment for its next programming period (GCF-2), the Strategic Plan reflects the urgency of the climate crisis and the organisation's growth and maturation in becoming even more transformative and accessible.</i></p> <p><i>The Strategic Plan sets out GCF's major programming directions for GCF-2, capturing the ambition to deliver both strengthened climate results and greater access for developing countries as the world heads into a critical decade for global climate action. It was also grounded on the latest scientific knowledge of the growing magnitude and urgency of the climate challenge, the present and intensifying impacts on developing countries, and the narrowing window of opportunity for action.</i></p>
