LESSONS LEARNT FROM THE GCF PROJECT IMPLEMENTATION: Moving forward

The Green Climate Fund approved its first batch of projects back in 2015 and as of November 2019, 124 projects have been approved, with almost half of them projects entering the implementation stage. This requires the GCF to put stronger focus on the implementation of approved projects and analyze whether those projects can meet their objectives and contribute to paradigm shift and transformational change. Additionally, the GCF is determined to remain a learning institution and extract lessons from project implementation during the initial results mobilization period in order to be able to achieve stronger impact during the its first resource mobilization phase.

This event will focus on lessons learnt from the GCF portfolio implementation. The event will provide an overview of the Annual Portfolio Performance Report (APPR) presented at its most recent board meeting and cover the current status of the portfolio, including lessons learnt and challenges. This will be followed by short presentations by four panelists from international accredited entities (IAE) and direct access entities (DAE), who will be invited to share their experience with implementing projects with the GCF. The presentation will be followed by panel discussion and Q&A.
