

## **Request for proposals (RFP 2017/C/ 016)**

### **Provision of consultancy services to review resource mobilization strategy and development of contribution policies for other alternative sources**

#### **1. Background**

- 1.1 The Green Climate Fund (Fund) was established with the purpose of making a significant and ambitious contribution to the global efforts towards attaining the goals set by the international community to combat climate change. In the context of sustainable development, the Fund will promote a paradigm shift towards low-emission and climate-resilient development pathways by providing support to developing countries to limit or reduce their greenhouse gas emissions and to adapt to the impacts of climate change. The Fund's headquarters are located in Songdo, Incheon City, Republic of Korea.
- 1.2 The GCF was designated as an operating entity of the financial mechanism of the United Nations Framework Convention on Climate Change ("UNFCCC"). It is governed and supervised by a Board that has responsibility for funding decisions pursuant to the Governing Instrument for the Green Climate Fund. It is supported by an independent Secretariat, accountable to the Board, having management capabilities to execute day-to-day operations of the GCF, providing administrative, legal and financial expertise.
- 1.3 The Secretariat has decided to seek the services of a consulting firm to deliver the advisory services and reports presented in Annex I Terms of Reference.

#### **2. Invitation**

- 2.1 Through this request for proposals ("RFP"), the GCF is seeking to employ a qualified, reputable and experienced Firm to deliver the advisory services and reports. The terms of reference included in Annex I provides the details of the assignment and expected deliverables.
- 2.2 Sealed Proposals must be submitted to the Secretariat no later than 6 October 2017 at 5.00 pm Korean time. Where proposals are sent via email, the Financial Proposal shall be password protected. The authorized procurement officer will contact the bidders that pass the qualifying technical score for the password to open the Financial Proposal.

- 2.3 The terms set forth in this RFP, including all the annexes listed above, will form part of any contract, should the Secretariat accept your proposal. Any such contract will require compliance with all factual statements and representations made in the proposal, subject to any modifications agreed to by the Secretariat in the context of any negotiations entered into it.

- 2.4 The GCF may, at its discretion, cancel the requirement in part or in whole. It also reserves the right to accept or reject any proposal and to annul the selection process and reject all proposals at any time prior to selection, without thereby incurring any liability to proposers/firms.
- 2.5 Proposers may withdraw the proposal after submission provided that written notice of withdrawal is received by the GCF prior to the deadline prescribed for submission of proposals. No proposal may be modified subsequent to the deadline for submission of proposals. No proposal may be withdrawn in the interval between the deadline for submission of proposals and the expiration of the period of proposal validity.
- 2.6 All proposals shall remain valid and open for acceptance for a period of 90 calendar days after the date specified for receipt of proposals. A proposal valid for a shorter period may be rejected. In exceptional circumstances, the GCF may solicit the proposer's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing.
- 2.7 Effective with the release of this solicitation, all communications must be directed only to Procurement Specialist by email at [procurement@gcfund.org](mailto:procurement@gcfund.org). Proposers must not communicate with any other personnel of the GCF regarding this RFP.
- 2.8 This RFP is issued under the GCF Administrative Procurement Guidelines<sup>1</sup>. - 2.9 The Guidelines apply for the interpretation of this procurement process.

### **3. Request for Clarification of RFP Documents**

- 3.1 A prospective proposer requiring any clarification of the solicitation documents may notify the GCF in writing at the GCF mailing or to the email address [procurement@gcfund.org](mailto:procurement@gcfund.org) by the specified date and time mentioned in Annex 6. The GCF will respond in writing to any request for clarification of the solicitation documents that it receives by the due date published on Annex 6. Written copies of the GCF response (including an explanation of the query but without identifying the source of inquiry) will be sent to all prospective proposers that have received the solicitation documents.
- 3.2 The RFP has been sent to other shortlisted bidders and therefore the results of any clarification exercise (including an explanation of the query but without identifying the source of inquiry) will be shared with all the shortlisted bidders.

### **4. Amendments to RFP Documents**

- 4.1 At any time prior to the deadline for submission of proposals, the GCF may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective proposer, modify the RFP documents by amendment. All prospective proposers that have received the RFP documents will be notified in writing of all amendments to the RFP documents.
- 4.2 In order to allow prospective proposers reasonable time in which to take the amendment into account in preparing their proposals, the GCF may, at its sole discretion, extend the deadline for the submission of proposal.

### **5. Language of Proposals**

- 5.1 The proposals prepared by the proposer and all correspondence and documents relating to the proposal exchanged by the proposer and the GCF, shall be written in English. Supporting documents and printed

literature furnished by the proposer may be in another language provided they are accompanied by an appropriate translation of all relevant passages in English. In any such case, for interpretation of the proposal, the translation shall prevail. The sole responsibility for translation and the accuracy thereof shall be the responsibility of the proposer.

## **6. Submission of Proposals**

- 6.1 Proposers shall submit their proposal in hard copy. Technical and financial proposals must be submitted simultaneously in separate sealed envelopes with the RFP reference and the clear description of the proposal (technical or financial) by the date and time stipulated in Annex 6. The two envelopes must be sealed in an outer envelope with the RFP reference and title.
- 6.2 Proposals must be sent **ONLY** to the address detailed below. Proposals sent to other addresses or to individuals will put offerors' proposals at risk of being rejected. Proposals sent via fax **WILL NOT BE ACCEPTED**.
- 6.3 Submission in hard copy may be done by post, courier or hand delivered. Both inner envelopes should indicate the name and address of the proposer. The first inner envelope should contain the proposer's technical proposal with copies duly marked "original" and "copy". The second inner envelope should include the financial proposal duly identified as such. If the envelopes are not sealed and marked as instructed, the GCF assumes no responsibility for the misplacement or premature opening of the proposals submitted.
- 6.4 Technical proposals shall be submitted in one (1) original envelope, clearly marked as technical proposal with two (2) additional copies and one (1) soft copy in the form of a CD or USB flash drive. Technical proposals (original, copies and soft copy) must be sealed in a specially marked envelope/package labelled:

- 6.5 Financial proposals should be submitted in one (1) original envelope on the forms prescribed herein. Financial proposals should be sealed separately in a specially marked envelope labelled:

- 6.6 Proposers are strongly recommended to use recycled paper for all printed and photocopied documents related to the submission of this proposal and fulfilment of this contract and shall, whenever practicable, use both sides of the paper.

Where proposals are sent via email, the Financial Proposal shall be password protected. The authorized procurement officer will contact the bidders that pass the qualifying technical score for the password to open the Financial Proposal.

6.8 All prospective proposers are kindly requested to return the completed Acknowledgement Letter of RFP receipt (Annex 5) by the date indicated in Annex 6, duly signed by an authorized representative, via email, advising whether it intends to submit a proposal by the designated closing date/time. Please also notify the Procurement Specialist immediately if any part of this RFP is missing and/or illegible.

## **7. Late proposals**

7.1 Any proposals received by the GCF after the deadline for submission of proposals prescribed in Annex 6 of this document may be rejected.

## **8. Opening of Technical Proposals**

8.1 Technical Proposals will be opened on the date indicated in Annex 6 in the room designated for this purpose at the premises of the Secretariat of the GCF. The purpose of this public opening is to record the names of proposers having submitted proposals by the due date and time. Only technical proposals will be opened at the public opening. The financial proposals will not be opened. Proposers submitting proposals are welcome to send one (1) representative, with proper authorization from their company, to observe the opening and recording of proposals received.

## **9. Opening of Financial Proposals**

9.1 After the technical evaluation is completed, the GCF shall notify those Proposers whose Proposals did not meet the minimum qualifying technical score that their Financial Proposals will be returned unopened after completing the selection process and Contract signing. GCF shall simultaneously notify in writing those Proposers that have achieved the minimum qualifying technical score and inform them of the date, time and location for the opening of the Financial Proposals.

9.2 At the opening, the names of the Proposers, and their overall technical scores shall be read aloud. The Financial Proposals shall be then opened, and the total prices read aloud and recorded.

## **10. Corrupt, Fraudulent, Coercive, Collusive and other Prohibited Practices.**

10.1 The GCF requires that all GCF staff, proposers/bidders, suppliers, service providers and any other person or entity involved in GCF-related activities observe the highest standard of ethics during the procurement and execution of all contracts. The GCF may reject any proposal put forward by proposers, or where applicable, terminate their contract, if it is determined that they have engaged in corrupt, fraudulent, coercive, collusive or other prohibited practices.

## **11. Conflict of Interest**

11.1 In their proposal, proposers must (i) confirm that, based on their current best knowledge, there are no real or potential conflicts of interest involved in rendering Services for the GCF, and (ii) set out their policy on dealing with conflicts of interest should these arise.

## **12. Confidentiality**

12.1 Information relating to the evaluation of proposals and recommendations concerning selection of Firms will not be disclosed to Firms that submitted proposals.

**Terms of Reference**

**Review, updates and development of Contribution Policies for other alternative sources**

**I. Introduction**

1. The Secretariat is mandated to support the Board in establishing policies for private foundations, philanthropies, and other alternative sources.
2. To achieve this, the Secretariat is seeking to engage a firm with relevant experience and a proven record on Review, updates and development of Contribution Policies for other alternative sources.

**II. Objective of the assignment**

- (a) The main objective of this assignment is to develop a revised version of the resource mobilization strategy plan and policies for contributions.

**III. Activities to be undertaken by the firm**

3. Under the guidance of the Division of CFO and Support Services of the GCF, the Firm will provide in-depth analysis on resource mobilization strategy and policies as they undertake the activities presented below:
  - (a) Assessing the operational priorities and action plan outlined in the Strategic Plan for the Initial Resource Mobilization period of 2016 to 2018 ("Strategic Plan") to identify funding requirements for activities in the Strategic Plan;
  - (b) Implementing base-line study of resource mobilization procedures of international organizations similar to GCF, such as Global Fund, GAVI and GEF.
  - (c) Developing a list of potential financing sources and match these to each activity using desk re-search and external stakeholder interviews. This will require landscape assessment of the existing climate finance funding sources, which should include traditional contributors (bilateral and multilateral funders), as well as non-traditional sources (e.g. state level funding, philanthropic foundations, private sector contributions and any other innovative finance sources);
  - (d) Outlining the guiding principles of the resource mobilization approach and the activities required to engage new and existing contributors.
  - (e) Producing the necessary draft policies for contributions to implement the above guiding principles and activities.
4. The advisory services provided will take into consideration the best practices and guidelines provided by the GCF, and also draw on the Firm's expertise and previous experience. Based on the lessons learned from countries, the Firm shall propose improvements to the resource mobilization from non-traditional contributors, best practices and guidelines, wherever applicable.
5. The Firm shall include in its proposal a detailed description of the services proposed, including a description of the tools and methodologies to be used to address the deliverables requested in these Terms of Reference.

#### IV. Work sessions

6. The Firm will be required to prepare and deliver initial interactive work session with the Secretariat per the schedule of deliverables provided below. The purpose of the interactive working sessions is detailed in this schedule of deliverables.
7. The Firm must provide budget for up to 2 (two) of these interactive sessions to take place on site, to allow for better communications based on demand from the GCF. On-site visits will be planned by the Firm in consultation with the GCF taking into account the need and the availability.
8. The Firm may present alternative approaches that they consider appropriate to deliver the objectives given above, in lieu of or in addition to the site visits. Whenever alternative approaches are presented, they should be accompanied by explanations that allow the GCF to clearly evaluate their value add and pertinence.

#### V. Deliverables

9. The Firm will prepare drafts and a final version of a resource mobilization strategy plan and policies for contribution. The firm will also prepare a compilation of these documents in a form that is consistent and comparable. The Report will, as a minimum:
  - (a) Present a thorough resource mobilization strategy analysis of the information from potential contributors and other relevant entities, as well as related documents supplied to the Firm by the GCF, including:
    - (i) A summary of lessons learned and best practices identified such as base-line study of replenishment procedures of international organizations similar to GCF, such as Global Fund, GAVI and GEF ;
    - (ii) Guiding principles and objectives of the resource mobilization approach, result framework, and activities;
    - (iii) A set of recommendations, emerging from the above-mentioned analysis, to improve resource mobilization policies, strategies, tools and guidelines; and,
  - (b) Produce draft policies for contributions, including its review of current policies for contribution and the policies for contribution from non-traditional contributors and/or other alternative sources.
10. The Firm shall take into account that the Report, both drafts and the final version, will be periodically presented to the GCF Board at its meetings to inform the Board in its consideration of the GCF's overall programming.

1. The proposals will be evaluated in a three stage procedure, with evaluation of the technical proposal being completed prior to any financial proposal being opened and evaluated. The financial proposal will be considered only if the submissions fulfil the minimum technical requirements.

#### **B. Acceptance of Submissions**

2. All proposers are expected to adhere to the requirements for submitting a proposal. Any proposals that fail to comply will be disqualified from further consideration as part of this evaluation. In particular:
